Ms. LeClair also provided significant details on the training curriculum and student-specific support (stipends) for each proposed awardee. Ms. LeClair highlighted the importance of the training opportunity for the students as well as the support to the industry sponsors in the MA ecosystem, which enhances the competitiveness of the MA life sciences.
